# Tom O' Sullivan

The following is an extract from an article published in echolive.ie on Tuesday 25 May, 2021 following the opening of TFC services in Tom O' Sullivan House.

Empowering and supporting the young people of Togher, in Tom O' Sullivan House, is a fitting tribute to the legacy of a man who was dedicated to supporting and promoting his community. Tom O' Sullivan was a proud voice for the people of Togher and was always keen to promote his locality. Tom represented his own estate (Deanrock) with passion and pride through his years as Chairman of the Deanrock Residents Association. He was also chairman of the Togher Community Association for many years. From the early 1970s Tom lobbied for the rights of council

tenants to be upheld. He was an active campaigner for safe and suitable accommodation for tenants and for the maintenance of their homes by the local authorities. A firm believer in standing up for what is right, Tom was also very involved in workers rights and trade unionism, both in his workplace as a printer for The Cork Examiner and with Council Trade Unions.

Mr O'Sullivan was actively involved in the campaign to deliver suitable and appropriate housing to the area, after the demolition of the Deanrock flats in 2007. He spoke publicly about the great community spirit and close family ties the residents of the N.B.A flats had in the area and urged local authorities to rehouse these residents in the locality where possible. Tom also highlighted the need for the flats to be replaced with units fit for purpose for young families and with adequate social supports in place. It would take more than 10 years of negotiations,

planning and drafts before construction would begin on the Shournagh Grove scheme, and Tom was involved throughout.

The naming of Tom O' Sullivan House, in Tom's honour, is bittersweet as Tom sadly passed away in January, 2019, before seeing the Shournagh Grove scheme completed. Speaking in a short film, Accommodating Togher, made in 2005, Tom expressed his wish for the demolition of the N.B.A flats to result in more than simply knocking one pile of bricks and replacing it with another. Tom stated that thought had to be given to the social infrastructure of the new housing scheme, highlighting the need for social workers and social supports to be in place. With The Pod being described as, "A bright light for Togher's Youth," and future social support services in the pipeline for Tom O' Sullivan House, the vision and community spirit of Tom O' Sullivan will continue to shine over his beloved community for many years to come.

We encourage staff and children to recycle as much as we can. There are segregated bins in all our services. Children are brought on walks to local recycling centres and are shown how to recycle waste materials.

## Food orders

In providing snacks, lunches, and dinners for our early years and youth services we co-ordinate food orders to ensure minimal food waste, value for money and freshness.

# Less Paper

We have embraced an eco-friendly take on the use of paper: All records are stored digitally. We also use our shredded paper for compost bins.

# Lighting

Togher Family Centres lighting is LED efficient, this means we use less energy from the grid and we save on costs.

# **Buildings**

Togher Family Centre is an insulated building, this means we save on heating costs and use less energy.

# Health & Safety

In August 2022 the following Fire Safety Works were completed at our Tús an Bhóthair Facility.

# **Emergency Lighting**

Emergency lighting have been fitted to the kitchen and WC's.

## **Smoke Seal**

Smoke seal has been fitted to the kitchen door, this is a requirement of the Building Regulations.

# **Disability Access**

Areas of the landings outside the final exit doors were extended to ensure safe disability access.

## **Extended Handrails**

Existing Handrails at the sides of the ramp and step were extended 300m beyond the end of each.

### **New Handrails**

New Handrails have been fitted at each side of the ramp and steps at the other side of the building.

# Tiny & Little Learners

The services we offer under the National Childcare Scheme are Tiny Learners (1-2 yrs) and Little Learners (2-3 yrs).

Both age groups are sessional services operating from August to June each year. Tiny Learners cater for fourteen children per day, per session. There are two sessions per day.

Little Learners cater for twenty one children per day, per session – with one session per day. While many children attend five days per week, there is an option when available to attend 2–3 days.

The services follow a play-based curriculum influenced by Aistear and guided by Síolta which supports the holistic development of the child.
Activities are planned, based on the children's emerging interests, and that are developmentally age appropriate.

Children who attend Tiny/Little Learners are automatically offered a place in one of our four preschool services.

There is a strong emphasis on relevant staff qualifications as well as personal and professional development. The early education we provide is up-to-date, appropriate and best practice.







## Early Years ECCE Preschool | 3-5yrs\*

# Our Four Preschools

The services we offer under the Early Childhood Care and Education scheme are; Tús an Bhóthair, Cur Le Chéile, Blossom Grove and Glentrasna.

ECCE offers two free years of preschool for children aged \*2yrs 8 months – 5yrs 8 months

Each of the four services cater for 22 children per session. They are sessional services operating from August to June each year.

The services follow a play-based curriculum influenced by Aistear and guided by Síolta which supports the holistic development of the child.

Our routine and structure of the day in preschool derives from emerging

interest from the children and also links in with our monthly plan. Each child has a key worker who takes observations of the child and communicates with their parents.

We have extra supports available such as the Access and Inclusion Model (AIM). This provides extra assistance in the room or specialised equipment when needed. This ensures every child attending the service is receiving the care and education they require.

There is a strong emphasis on relevant staff qualifications as well as personal and professional development. The early education we provide is up-to-date, appropriate and best practice.









## Meeting the Needs of Cork

In November 2021, Togher Family Centre acquired Glentrasna Pre-school and took over the management of the service from the Glentrasna Board of Trustees.

During 2022 TFC invested in the renovation of Glentrasna while still maintaining a service for the children attending.

During the summer we continued our improvements with a new outdoor playground and a full repainting of the interior of the services.

In August 2022 we were delighted to take full ownership of Glentrasna preschool and in that same month we welcomed 22 children and families to Glentrasna as part of Togher Family Centre Services.

New Funding Model

TFC registered with the new core funding model in August 2022.

This new funding model supports the delivery of Early Learning and Care and aims to improve quality of early years education for the public good.

This model also supports better wage equity for those employed in the Early Years Sector.





## **Cork Education & Training Board**

# Community Education

Adult and community classes are a big part of Togher Family Centre and important to those that avail of them.

Classes encourage self-care skills through yoga and increase their craft skills, creative art, knitting and sewing.

Classes offered are:

- Womans Active Group
- Arts and crafts
- Art (Morning and Evening)
- Yoga (Morning and Evening)

These classes run weekly during term time and are 2 hours each week per course. There is a dedicated CETB tutor who facilitates these classes. Annually, approximately 300 hours are provided yearly to approximately 66 participants.

The classes offer a range of benefits for the adults in the community both socially and educationally. The requirements for the classes were established through listening to the needs of the community.

# Happy Hub

Situated in our Maglin Grove premises, Happy Hub is available to school children in Junior infants to 3rd class (4 – 9yrs).

Happy Hub offers one to one support to children when required. Happy Hub also provides homework support, home cooked meals and outings each term. Children then transition to The Pod - our senior youth resilience project. A range of activities are provided and built around 8 key themes which promote resilience, these are;

- Managing Feelings
- Confidence
- Planning and Problem Solving
- Relationships
- Resilience
- Determination
- Creativity
- Communication



Activities are built around eight key themes which promote young people's resilience.



# Youth Resilience | 10 - 12yrs

# The Pod

Situated in Tom O'Sullivan House in our Shournagh Grove premises The Pod is available to school children in 4th class to 6th class (10 – 12yrs). The Pod is funded under the UBU CETB.

The Pod is part funded under the UBU CETB. The young people get support with their school homework and actively engage in a mix of structured small group activities and freeplay which are focused on the 7 personal

and social developmental outcomes as outlined in UBU quiding documents.

- Communication skills
- Confidence and agency
- Planning and problem solving
- Relationships
- Creativity and imagination
- Resilience and determination
- Emotional intelligence



The Pod provides outings each term and operates a drop-in service and one to one support weekly.

# Financial Review

It is the policy of the charity that unrestricted funds which have not been designated for a specific use should be maintained at a level equivalent to three months expenditure.

# Independent Auditors Report
